1. School should comply with the Right of Children to Free and Compulsory Education Act 2009 (Enclosed Letter 1) and the Right of Children to Free and Compulsory Education Rules, 2011(Enclosed Letter 2).
2. School should reserve 25% of the admission for 1st Standard for children from socially and economically backward classes of the nearby locality of the School. School should also provide such children the free and compulsory education still completion of primary school as well ensure the free and compulsory education for pre primary school education.
3. School should open a separate bank account for getting recurring aid/grant under Section 12(2) of the Right of Children to Free and Compulsory Education Act, 2009, in respect of children referred in para 3 above.
4. The School or Institute should not accept any capitation fee or should not obliged any child or their parents to go through the selection process.
5. No child should be denied the admission to the School on account of non-submission of age proof, religion, caste or place of birth.

6. (One) the Child should be retained in the class where he has admitted to the School or should not be removed from the School until the completion of his primary education.

(Two) No child should be punished physically or harassed mentally.

(Three) No child is under obligation to pass the examination of any Education Board, still he completes his primary education.

(Four) Certificate prescribed under Section 23 should be provided to the child who completes his primary education.

(Five) Physically handicapped child should be admitted in compliance with the Act.

(Six) Teachers having the qualification prescribed under Section 23 (1) should be appointed. Teachers who are appointed before the commencement of the Act should get qualified under Section 23(1) within the period of five years.

(Seven) Teachers should comply with their obligations prescribed under Section 24(1) of the Act.

(Eight) School should ensure that teachers are not conducting any private
